## Entrance Counseling & Master Promissory Note

- Log in to the Federal Direct Loan website <https://studentaid.gov>
- Complete the **Entrance Counseling**
  - Add School to Notify and select student type I am an **undergraduate student**
  - There are 5 steps to complete:
    - \*1-Understanding Your Loans
    - \*2-Manage Your Spending
    - \*3- Plan to Repay
    - \*4- Avoid Default
    - \*5- Finances: A Priority
  - **Submit Entrance Counseling**
- Go to **MENU** and under **My Account** select **My Home Page**
- Click on **Complete Master Promissory Note**
- Select **MPN for Subsidized/Unsubsidized**
- Complete the 4 steps to electronically sign (e-sign) your MPN:
  - Step 1 - Information
  - Step 2 - References
  - Step 3 - Review & Edit
  - Step 4 - Sign & Submit
- Log out

## Federal Direct Loan Award

- Log in to <https://my.epcc.edu>
- Select **Self Service (Web Banner)**
- Log in using your user@my.epcc.edu and password
- Select **Financial Aid**
- Go to **Award Year** and select: **2023-2024 Aid Year**
- Go to **Award Offer**
- Go to **Option to Pay Net Cost**
- Go to **Loans**
- Click on **Take Action:**
- Select your Award Decision (Accept, Decline, Modify). **You cannot decline the Subsidized Federal Direct Loan**, if offered both Subsidized and Unsubsidized Federal Direct Loans.
- Submit Decision
- Exit
