All early voting locations will be open on Saturday, May 2 (hours: 9:00 a.m. – 6:00 p.m.) and Sunday, May 3 (hours: 12:00 p.m. – 5:00 p.m.) In addition, all early voting locations will be open from 7:00 a.m. – 7:00 p.m. on Monday, May 4 and Tuesday, May 5. If a run-off election is necessary for any single electoral district, the run-off election may be conducted on June 13, to be determined by the El Paso County Elections Administrator, and to provide for early voting, which will be determined depending on the date selected for the Run-off Election.


