I. Catalog Description

Examines the record of humankind's perception of the universe through painting, sculpture, and architecture, from the Paleolithic through the Gothic/Early Renaissance Era. **Prerequisite: READ 0309 Or INRW 0311 or ESOL 0340 (can be taken concurrently) or by placement exam. (3:0).**

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Explain and interpret the relationship of art to human experience, through the visual language of art.
- B. Categorize and interpret artistic movements according to their historic and social significance.
- C. Visually identify art creations of Prehistory through Pre-Renaissance art to include a broad range of art including the utilitarian and art as a function of community, religion, and political power.
- D. Recognize the social and cultural development of art within regional, national, and global societies.
- E. Understand the visual record of art as an expression of the philosophical and cultural achievements of humanity through a historic and social context.

III. Evaluation

- A. Pre-assessment
