I. Catalog Description

Provides a study of three-dimensional forms and contemporary sculptural concepts related to basic materials and forming techniques. Provides focus on studio production, safety, and aesthetic criticism techniques. **Prerequisite: ARTS 1311. (2:4). Lab fee.**

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Visually present and expressively communicate understanding of volumetric form.
- B. Execute concepts of abstraction in the assigned three-dimensional projects.
- C. Exhibit skills in utilizing assigned materials necessary in three dimensional compositions adequate for exhibition.

III. Evaluation

- A. Pre-assessment

There is no pre-assessment for this course.

- B. Challenge Exam

There is no challenge exam for this course.

- C. Postassessment

Each student's grade will be determined by the instructor upon successful completion of the course objectives. Instructors will maintain adequate records of student progress according to the guidelines established by the college.
