## I. Catalog Description

Applies the use of the performer's voice as a creative instrument for effective communication, based on the Arthur Lessac Approach to Voice Training. Utilizes a sensory approach by feeling the dynamics of energy and feeling the sound. Provides comprehensive coverage of all aspects of voice and speech, while relaxing and energizing the body at the same time. Completing this course will be beneficial to all those wishing to improve their speaking voice: actors, singers, teachers, and clergy. (3:0).

Upon satisfactory completion of this course, the student will be able to

- A. Utilize efficient breathing techniques.
- B. Walk and stand with proper body posture and alignment.
- C. Relax and energize oneself for any physical or speaking assignment.
- D. Support daily and performance speech in a healthy way.
- E. Develop skills in speech projection, articulation, and phrasing.
- F. Employ the three vocal and physical energies in his/her daily life.
- G. Develop the ability to be informed and analytic as he/she approaches life and any form of vocal expression.
