I. Catalog Description

Develops English reading proficiency and vocabulary for academic, career, or personal purposes in speakers of languages other than English and prepares them to function in a multicultural, multilingual society. Low intermediate level. May not be counted toward graduation requirements. A grade of "C" or better will be required for completion of this course. **Prerequisite: Assessment of English language proficiency or ESOL 0315. (3:1). Lab fee.**

II. Course Objectives

Since this class is designed to prepare non-native speakers of English for academic courses, students are expected to use English in class at an appropriate level. Moreover, writing, reading, grammar, and listening and speaking activities will be incorporated throughout the course.

Upon satisfactory completion of this course, the student will be able to:

- A. Read at the required reading level as measured by an appropriate reading selection or selections chosen by the discipline.
- B. Demonstrate the writing process in three- paragraph essays containing simple, compound, and complex sentences with correct grammatical structures in the following rhetorical styles: narrative, descriptive, expository, and compare/contrast using appropriate proficiency in written and oral communication.
- C. Identify the following elements, transitions, and organizational patterns after reading assigned materials:
 1. Elements: topic/main idea/thesis/major details
 2. Modes of writing: narrative, descriptive, expository
 3. Patterns: Listing, Chronologic Order, Classification, and Compare/Contrast
- D. Read, recognize, and correct grammar, spelling, and punctuation errors in paragraphs.
- E. Define words using context clues, structural analysis, and the English dictionary in a reading selection.

- F. Create concept maps and/or outlines demonstrating the main idea and major details with pre-writing exercises for three- paragraph essays and post-reading exercises.
- G. Respond orally and in writing to open-ended literal and inferential questions based on students-generated writings and instructor-assigned reading materials.
- H. Demonstrate the reading process such as SQ3R.
- I. Summarize instructor-assigned reading selections in writing and orally.

III. Evaluation

A. Placement

Enrollment in ESOL 0316 is determined by placement test score or successful completion of ESOL 0315.

B. Assessment

1. Students will demonstrate successful attainment of the course objectives through instructor assigned activities which can include the development of a portfolio, reading logs, writing samples, tests, quizzes, and where appropriate graded speaking activity
 2. Students must have a 70% or higher to take the Exit Exams and must pass the course Exit Exam with a score of 70% or better. The Exit Exam includes a reading section and writing section. If a student passes one and does not pass the other, the student may take a second exam in the area they did not pass. However, if a student did not pass both sections, they do not have a second chance to take the Exit Exam. Students must have a passing grade in the course and the Exit Exam to pass the course.
 3. Students are required to complete all lab activities for this course. Refer to lab manual for details.
- C. It is agreed that the percentage weight of reading and writing assignments will be equal and that a minimum of 40% of the student's grade shall be derived from writing assignments consisting of 6-8 essays of 250-350 words, a minimum of 40% shall be derived from Reading assignments and no more than 20% from other evaluations (e.g. - lab, participation, etc.). Lab work cannot count more than 15% of the final grade.

Note: A grade of C or better is required for advancement to the next course.
