**I. Catalog Description**

Continues the study of combination, transmission, and effects of musical sounds, utilizing symbols.  
**Prerequisites:** MUSI 1116 and MUSI 1311. **Corequisite:** MUSI 1117. (3:0).

**II. Course Objectives**

Upon satisfactory completion of this course the student will be able to:

Unit I. General Review of Fundamentals of Music including Music 1311.

- A. Play on the keyboard and write all major and minor scales and seventh chords.
- B. Analyze selected compositions, when heard and from the musical score, in terms of: tonality, melody, harmony, rhythm, texture and form.

Unit II. Triads in second inversion

- A. Having given a major-minor .chord,
  - 1. Determine the root, first and second inversion
  - 2. Recognize the unstable quality of the second inversion aurally
- B. Having given scores of musical excerpts:
  - 1. Rewrite the chords in simple positions.
  - 2. Make complete harmonic analyses of examples supplied
- C. Having given musical excerpts with figured basses:
  - 1. Identify any six four chords by type analyze with Roman numerals and label six-four Types.
  - 2. Play on keyboard.
- D. Having given a figured bass formula illustrating the characteristic uses of the six-four chord:
  - 1. Work each out in four parts.
  - 2. Play on keyboard.

### **III. Evaluation**

- A. Tests will be given at the end of chapters 9, 11, 13 and 15 of the textbook, and a final exam at the end of the course. Each test will have two parts, a paper and pencil test and a keyboard performance test.
- B. Scores on the tests and the final exam will be averaged to find the percent score for the course. Percent scores will be converted to letter grades according to the following scale:

90 to 100	=A
80 to 90	=B
70 to 80	=C
60 to 70	=D
below 60	=F
