I. Catalog Description

Provides a chronological analysis of the historical and cultural contexts of painting, sculpture, architecture, and related visual arts from prehistoric times to the 14th century. **Prerequisite: READ 0309 or INRW 0311 or ESOL 0340 (can be taken concurrently) or by placement exam or ENGL 1301 with a “C” or better or ENGL 1302 with a “C” or better. (3:0).**

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Explain and interpret the relationship of art to human experience, through the visual language of art.
- B. Categorize and interpret artistic movements according to their historic and social significance.
- C. Visually identify art creations of Prehistory through Pre-Renaissance art to include a broad range of art including the utilitarian and art as a function of community, religion, and political power.
- D. Recognize the social and cultural development of art within regional, national, and global societies.
- E. Understand the visual record of art as an expression of the philosophical and cultural achievements of humanity through a historic and social context.

III. Evaluation

- A. Pre-assessment

There is no pre-assessment for this course.
