## I. Catalog Description

Emphasizes interpretive and expressive drawing from the model and concludes with introduction to a conceptual approach toward figure drawing with experimentation of new media. **Requirements: ARTS 1317 and ARTS 2323. (2:4).** Lab fee.

# II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Perceive, understand, and draw the skeletal and muscular structure of the human figure from the text, the studio skeleton, and live model.
- B. Use anatomical information in drawing the human figure in motion, and in establishing, by means of line quality, chiaroscuro, and background reference, the figure in space.
- C. Compose drawings of two or more figures in compositional relationship to each other.

#### III. Evaluation

#### A. Pre-assessment

Instructor should check each student's prerequisites the first week of class; those who do not qualify should be sent back to Admissions.

## B. Challenge Exam

There is no challenge exam for this course.

#### C. Postassessment

Each student's grade will be determined by the instructor upon successful completion of the course objectives. Instructors will maintain adequate records of student progress according to the guidelines established by the college.
