# I. Catalog Description

Emphasizes personal exploration using various printmaking techniques. **Prerequisite: ARTS 2333.** (2:4). Lab fee.

# II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Explore a specific interest in lithography as an individual pursuit of expression.
- B. Propose a particular problem or area of lithographic exploration or a series of related projects using the techniques learned in Print Making I.

## III. Evaluation

A. Pre-assessment

Instructors should check each student's prerequisites the first week of class; those who do not qualify should be sent back to Admissions.

B. Challenge Exam

There is no challenge exam for this course.

C. Post-assessment

Each student's grade will be determined by the instructor upon successful completion of the course objectives. Instructors will maintain adequate records of student progress according to the guidelines established by the college.
