I. Catalog Description

Presents the theory and practice of nail services. Develops terminology, application, and workplace competencies related to nail services. A passing grade is required in this course to take the second semester courses. Prerequisite: READ 0308 or by placement by exam. Corequisites: CSME 1505 and CSME 1553. (2:8). Lab fee. Professional Practice Insurance required.

II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Recognize nail disorders and diseases.
- B. Demonstrate massage techniques used when giving a manicure or pedicure.
- B. Define and demonstrate the different types of manicures.
- D. Demonstrate the procedure for a pedicure.

III. THECB Learning Outcomes (WECM)

- 1. Identify terminology related to nail services; demonstrate the basic procedures of nail services.
- 2. Practice workplace competencies in nail services.

IV. Evaluation

A. Grading Criteria

Students are assigned theory study and a minimum number of practical experiences required for course completion. Theory (lecture) is evaluated after each unit of study by an exam or quiz. Practical assignments (lab) are evaluated as completed. Practical skills are evaluated according to state requirements or instructor procedures. The Texas Department of Licensing & Regulations (TDLR) establishes practical performance standards.

Make-up tests will be given according to Departmental Policies. *There will be no make-up testing for failed exams.*

The overall Semester grade is evaluated as follows: 50% Lecture and 50% Lab work.
