I. Catalog Description

Provides an introduction to heating, ventilation, and air conditioning theory, testing, and repair. Emphasizes refrigerant reclamation, safety procedures, specialized tools, and repairs. **(2:3). Lab fee.**

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Analyze heating, ventilation, and air conditioning systems.
- B. Repair or replace components utilizing special tools.
- C. Comply with personal and environmental safety practices associated with clothing; eye protection; hand tools; power equipment; proper ventilation; and the handling, storage, and disposal of chemicals/materials in accordance with federal, state, and local regulations.
- D. Perform all practices and procedures according to current mandates, standards, and regulations.
