Provides a comprehensive overview of safety rules and regulations. Includes the selection, inspection, use, and maintenance of common tools for electricians. Emphasizes OSHA and NEC code compliance.

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to

- A. Practice eye and hearing safety with safety glasses and hearing protection.
- B. Utilize safe procedures when using step and extension ladders on the job site.
- C. Safely operate the hand and power tools common to electrical work.
- D. Proficiently operate the multi meter and other electrical devices used by the electrician.
- E. Apply the OSHA rules for Electrical Safety.
- F. Use the terminology of the electrical trade and the rules in the NEC code and definitions.
- G. Identify work limitations.
- H. Treat others with respect and display effective customer service.
- I. Follow instructions.
- J. Demonstrate the self-confidence to ask questions.
- K. Practice personal time management.
- L. Document on-the-job training hours and duties.
- M. Introduction to CPR and First Aid.

III. THECB Learning Outcomes (WECM)

- 1. Explain electrical hazards and how to avoid them in the workplace.
- 2. Discuss safety issues concerning lockout/tagout procedures.
- 3. Demonstrate safe work habits using common hand and power tools for electricians.
