### I. Catalog Description

Offers piano instruction, first semester. Open to all. **Prerequisite: READ 0309 or INRW 0311 or ESOL 0340 (can be taken concurrently) or by placement exam or ENGL 1301 with a “C” or better or ENGL 1302 with a “C” or better. (0:3).**

### II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Demonstrate the use of proper fingering, hand position, and control on the keyboard through playing the five finger patterns and chords in all twelve keys in parallel motion.
- B. Sight read and play easy piano literature, solo, or in ensembles.
- C. Demonstrate an understanding on basic music symbols and terminology, basic rhythm patterns, simple notation, basic chords.

### III. Evaluation

- A. The student will be evaluated on the basis of 6 piano performance tests of assigned material (C hand position, G hand position, eighth notes, dotted quarter/eighth note combinations, five finger patterns and I-IV-V7 chords) and 5 class review tests of notation, rhythm, and harmony that will be either written or oral.
- B. The final exam will include written work over the principles of notation, rhythm, and harmony, as well as the performance of one piece selected by the student and the instructor.
- C. Grades from the 6 keyboard performance tests and 5 class review tests will be added to the final exam and converted to the following scale:

90 to 100	=	A
80 to 90	=	B
70 to 80	=	C
60 to 70	=	D
below 60	=	F
