### I.      **Catalog Description**

Continues piano instruction, second semester. Open to all. **Prerequisite: MUSI 1181. (0:3).**

### II.     **Course Objectives**

Upon satisfactory completion of this course the student will be able to:

- A. Demonstrate the use of proper fingering, hand position, and control on the keyboard through playing the major scales in parallel motion two octaves and chords hands together.
- B. Sight read and play moderately easy piano literature, solo, or in ensembles.
- C. Demonstrate an understanding of more extensive music symbols and terminology, more complex rhythm patterns, and basic harmony.

### III.    **Evaluation**

- A. The student will be evaluated on the basis of 6 piano performance tests of assigned material (major/minor, compound rhythms, sixteenth notes, dotted eighth/sixteenth note combinations, 12 major scales with I-IV-V7 chords) and 5 class review tests on notation, rhythm, and harmony, that will be either written or oral.
- B. The final exam will include written work over the principles of notation, rhythm, and harmony, as well as the performance of one piece selected by the student and the instructor.
- C. Grades from the 6 keyboard performance tests and 5 class review tests will be added to the final exam and converted to the following scale:

90 to 100	=	A
80 to 90	=	B
70 to 80	=	C
60 to 70	=	D
below 60	=	F
