### I. Catalog Description

Continues to provide experience in aural recognition of tone relation through sight-singing and keyboard activities. **Prerequisites:** MUSI 2116. **Corequisite:** MUSI 2312. (1:1). (2:0).

### II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Sing major and minor scales, intervals, and simple melodies at first reading.
- B. Recognize major and minor scales and keys; major and minor interval; major, minor, augmented and diminished chords; and chord progression by ear.
- C. Notate two-part and four-part dictation accurately in pitch with the proper rhythmic values.
- D. Recognize and notate chord inversions.

### III. Evaluation

- A. Test and quizzes will be given to determine the student's progress and understanding of the course material. A minimum of three tests three quizzes, and a final exam will be administered.
- B. Scores on the test, quizzes and final exam will be averaged to find the percent score for the course. Percent scores will be converted to letter grades according to the following scale:
