### I. Catalog Description

Develops skills in therapeutic practices relating to the field of radiation therapy with emphasis on basic patient set up, treatment technique and portal imaging. A grade of a "C" or better is required in this course to take the next course. (1:3). Lab fee.

Upon satisfactory completion of this course, the student will be able to

- A. Demonstrate use of the following Radiation Therapy Equipment: simulators, superficial and orthovoltage units, megavoltage units (linear accelerator and specialized units), and emerging technologies
- B. Provide patient care-giving
- C. Localize tumors
- D. Perform patient positioning and reproducibility
- E. Expose radiographs
- F. Process images
- G. Delineate and measure treatment field
- H. Document treatment parameters
- I. Observe and communicate appropriately with patients during treatment
- J. Perform emergency medical procedures
- K. Utilize beam directional devices and beam modification devices
- L. Utilize patient positioning and immobilization devices
