I. Catalog Description

Provides a chronological analysis of the historical and cultural contexts of painting, sculpture, architecture, and related visual arts from the 14th century to the present day. **Prerequisite: READ 0309 or INRW 0311 or ESOL 0340 (can be taken concurrently) or by placement exam or ENGL 1301 with a "C" or better or ENGL 1302 with a "C" or better. (3:0).**

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Explain and interpret the relationship of art to history through the visual language of art.
- B. Categorize and interpret artistic movements according to their historic and social importance.
- C. Visually identify art creations of the Renaissance through the Modern Art era which also includes art movements, styles, and work of the individual artist.
- D. Recognize the social and cultural development of art within regional, national, and global societies.
- E. Understand the visual record of art as an expression of the philosophical and cultural achievements of humanity through a historical context.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Identify and describe works of art based on their chronology and style, using standard categories and terminology.
- 2. Investigate major artistic developments and significant works of art from the 14th century to the present day.
- 3. Analyze the relationship of art to history by placing works of art within cultural, historical, and chronological contexts.
- 4. Critically interpret and evaluate works of art.
