### I.      **Catalog Description**

Explores advanced techniques and in-depth exploration of ideas using jewelry and art metals construction.

**Prerequisite: ARTS 2341. (2:4). Lab fee.**

### II.     **Course Objectives**

Upon satisfactory completion of the course, the student will be able to:

- A.      Identify the terminology of metalsmithing and use it effectively to express his/her ideas verbally.
- B.      Describe basic metalsmithing techniques for fabrication, casting, repousee, stone setting, and chain making.
- C.      Perfect craftsmanship and working habits needed to achieve strong three-dimensional visual statements.
- D.      Create properly composed, well balanced three-dimensional designs using sheet metal, wire, tubing, and various non-metal materials.
- E.      Develop of an advanced level of visual literacy
- F.      Effectively apply expanded metalsmithing skills and techniques to create his/her own three-dimensional statements.

### III.    **Evaluation**

#### A. Pre-assessment

Instructors should check each student's prerequisites the first week of class; those who do not qualify should be sent back to Admissions.

#### B. Challenge Exam

There is no challenge exam for this course.

#### C. Post-assessment

Each student's grade will be determined by the instructor upon successful completion of the course objectives. Instructors will maintain adequate records of student progress according to the guidelines established by the college.
