I. Catalog Description

Provides basic instruction in photographic materials, equipment, and techniques for creative application in the visual arts. (2:4). Lab fee.

Upon satisfactory completion of the course, the student will be able to:

- A. Use the photographic process to create a personal interpretation of the world.
- B. Learn to use the photographic image as a means of social commentary about the community at large.
- C. Learn to chemically process and critically evaluate both black and white prints and negatives.
- D. Analyze and use critical thinking skills to evaluate photographic compositions in terms of technique and visual content in a group and/or individual classroom setting.
