**I. Catalog Description**

Prepares the students for the State Licensing Examination. Successful completion of the second semester courses required prior to taking this course. A passing grade is required in this course to qualify for the State Licensing Examination. **Prerequisite: CSME 1505 (3:8). Lab fee. Professional Practice Insurance required.**

**II. Course Objectives**

Upon satisfactory completion of this course the student will be able to:

- A. Demonstrate knowledge of general exam information
- B. Perform a TDLR Standard manicure.
- C. Demonstrate a basic facial per TDLR Requirements.
- D. Perform basic applications of a Virgin Tint, Bleach Retouch, and Chemical Hair Relaxer.
- E. Demonstrate a basic 90 degree haircut.
- F. Perform a basic Perm Wrap.
- G. Demonstrate a basic curl demonstration, to include roller, pin curl and finger wave.
- H. Perform a basic blow dry and curling iron curl, per TDLR grading criteria.
- I. Identify what supplies and equipment is needed for the exam.
- J. Take TDLR and PSI exam with confidence.

**III. THECB Learning Outcomes (WECM)**

- 1. Review for the state licensing exam.
- 2. Prepare for the practical state licensing exam.
- 3. Practice safety and sanitation according to the laws and rules of the state licensing agency,

**IV. Evaluation**

- A. Grading Criteria

Students are assigned theory study and a minimum number of practical experiences required for course completion. Theory (lecture) is evaluated after each unit of study by an exam or quiz. Practical assignments (lab) are evaluated as completed. Practical skills are evaluated according to state requirements or instructor procedures. The Texas Department of Licensing & Regulations (TDLR) establishes practical performance standards.

Make-up tests will be given according to Departmental Policies. *There will be no make-up testing for failed exams.*

The overall Semester grade is evaluated as follows: 50% Lecture and 50% Lab work.

**B. Grading Scale**

Student grade will be determined according to the following grading scale:

64 – 0 = F
