I. Catalog Description

Provides in-depth coverage of the study of the National Electrical Code (NEC) for those employed in fields requiring knowledge of the Code. Emphasizes wiring protection and methods, special conditions, and advanced calculations. Emphasizes preparation for the Texas Journeyman Electrician exam.

Highly recommended completing ELPT 1325 before registering for ELPT 2325. (3:1).

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Define electrical terms.
- B. Interpret working drawings for wiring and protection of the electrical circuits.
- C. Identify various wiring methods and materials (Article 300).
- D. Recognize the different types of equipment for general use of flexible cords and cables (Article 400).
- E. Identify special occupancies of hazardous (classified) locations under Article 500.
- F. Recognize special equipment for electrical signs and outline lighting under Article 700.
- G. Develop communication circuits and systems under Article 800.
- H. Perform box/conduit fill calculations.
- I. Employ correct conduit bending methods.
- J. Emphasis on grounding.

III. THECB Learning Outcomes (WECM)

- 1. Explain hazardous location classifications and divisions and wiring methods allowed in these locations.
- 2. State the rules for electrical installation in special locations.
- Calculate conductor sizes and overload protection required for residential, commercial, and industrial locations.
- 4. Select appropriate sections in the NEC for specific applications.
