I. Catalog Description

Provides an introduction to drawing with emphasis on descriptive, expressive and conceptual approaches. Students will learn to see and interpret a variety of subjects while using diverse material and techniques. Students will engage in critical analysis of drawing as a discipline. May include life drawing using a live model. (2:4). Lab fee.

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- Analyze and represent a variety of subjects including basic geometric forms, still-life subjects, and the natural world.
- B. Analyze and represent a three-dimensional form onto a two-dimensional surface using measurement and comparison. Analyze and represent the effects of light and shadow as a means of expressing three-dimensional space and form on a two-dimensional surface. Demonstrate linear, one-point and two-point perspective as observable representations of visual space.
- C. Use critical thinking skills to evaluate visual content in a group and/or individual classroom setting.
- D. Through creative and critical thinking, apply suitable drawing media towards visual expression of the observed world.
- E. (Optional) Understand basic anatomy and be able to draw the human figure in contour and gesture working from a live model.

Upon successful completion of this course, students will:

- 1. Describe visual subjects through the use of accurate and sensitive observation.
- 2. Generate drawings which demonstrate descriptive, expressive, and conceptual approaches.
- Utilize varied materials and techniques with informed aesthetic and conceptual strategies.
- 4. Demonstrate an appropriate level of professional practice, including safety, craft and presentation.
- 5. Analyze and critique drawings verbally and/or in writing.
- 6. Relate drawing to design, art history and contemporary artistic production.
