Provides a study of three-dimensional forms and contemporary sculptural concepts related to basic materials and forming techniques. Provides focus on studio production, safety, and aesthetic criticism techniques. **(2:4). Lab fee.**

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Visually present and expressively communicate understanding of volumetric form.
- B. Execute concepts of abstraction in the assigned three-dimensional projects.
- C. Exhibit skills in utilizing assigned materials necessary in three dimensional compositions adequate for exhibition.

- A. Pre-assessment
