**I. Catalog Description**

Introduces the basics of relief, intaglio, and lithographic printmaking techniques, including the terminology, and brief history of these processes. Students will learn to develop personal original imagery that will be executed in these media. **(2:4). Lab fee.**

**II. Course Objectives**

Upon satisfactory completion of the course, the student will be able to:

- A. Identify equipment, processes, and materials used in printmaking beginning with a drawing and culminating in a final print.
- B. Draw, etch, and print a finished lithograph based on demonstrations provided by the instructor.
- C. Draw, etch and print a finished intaglio image based on demonstrations provided by the instructor.
- D. Draw, carve, and print a finished relief image based upon demonstrations provided by the instructor.
- E. Use critical thinking skills to evaluate visual content in a group and/or individual classroom setting.

**III. Evaluations**

- A. Pre-assessment

There is no pre-assessment for this course.

- C. Post-assessment

Each student's grade will be determined by the instructor upon successful completion of the course objectives. Instructors will maintain adequate records of student progress according to the guidelines established by the college.
