# I. Catalog Description

Provides individual study emphasizing creative form, techniques, and materials using the potter's wheel and hand-building techniques. Emphasizes glaze and clay formulation with individual practice in kiln operation. **Prerequisite: ARTS 2346. (2:4). Lab fee.** 

#### II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Throw bowls (small and large) and cylinders (6 inches high) on the potter's wheel.
- B. Create thrown clay works with pulled handles, fitted lids, and trimmed feet.
- C. Throwing bottles and donuts.
- D. Create larger clay works by joining thrown pieces.
- E. Make a two-piece mold for slip-casting multiple pieces.
- F. Load, fire and unload kilns with minimal supervision.
- G. Create a glaze from scratch and prepare glazes.
- H. Participate in the presentation completed clay work.
- I. Exhibit use of relevant vocabulary, theory, and history.

### III. Evaluation

#### A. Pre-assessment

Instructors should check each student's prerequisites the first week of class; those who do not qualify should be sent back to Admissions.

There is no challenge exam for this course.
