I. Catalog Description

IV. Evaluation

- A. Evaluation Methods
 - Four (4) written tests will measure a student's understanding of the course content and will account for 400 points toward the final grade.

It is the student's responsibility to make <u>prior</u> arrangements with the instructor if the student is unable to attend class the day of <u>any</u> exam. <u>A grade of zero (0) will be given if an exam</u> is not taken and no prior arrangements to take the exam have been made. If prior arrangements have been made, the test may be administered at the instructor's convenience at the testing center.

2. The lowest grade of the four exams will be dropped if a written report on a criminal justice topic is submitted prior to Finals Week. The report will represent 25% of the final grade. The report will be at least twelve double-spaced paper in length and will be written in a scholarly manner using either the APA or MLA format. The paper will have a bibliography, or reference page, and the references will be noted within the body of the paper.

Deductions will be made for each error: not following directions, proofreading, formatting, typographical problems including incorrect text, etc. A percentage grade will be assigned by dividing the total points earned by the total points possible.
