#### I. Catalog Description

Continues DRAM 1351. Continues to build upon skills developed in Acting I with a special emphasis on scene study and script analysis. Performance rehearsal lab participation is required for all students registered for Acting II. **Prerequisite: DRAM 1351. (3:0).** 

### II. Course Objectives

Upon satisfactory of this course, the students will be able to:

- A. Participate in the art of theatrical performance.
- B. Portray a variety of characters in order to enhance acting ability.
- C. Study, analyze and perform a minimum of three monologues, soliloquies or solo performance.
- D. Study, analyze and perform a minimum of three duet scenes with a partner of the class.
- E. Study, analyze and perform one ensemble selection where students show the "group" experience of performance.
- F. Study, analyze and learn about themselves as individuals in order to accurately portray other characters.
- G. Participate in theatrical games in order to ease the tension and provide comfortable performance atmosphere.
- H. Improvise real life situations in order to build quick character traits in a spontaneous atmosphere.
- I. Improvise implausible situations in order to build spontaneity, creativity and imagination.
- J. Develop a sense of pride, self-worth and accomplishment.

- 1. Analyze scripts more in depth from the viewpoint of the actor.
- 2. Analyze, develop, and perform more complex characters.

- 5. Perform at an increasingly skilled level in ensemble building exercises, scenes and final projects, which may include participation in plays.
- 6. Analyze and critique personal and peer performances.
