I. Catalog Description

Further explores painting media and techniques with increased emphasis on critical analysis of painting as a discipline. **Prerequisite: ARTS 2316. (2:4). Lab fee.**

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Prepare traditional/non-traditional support systems for painting such as: stretcher/strainer bars, stretched canvas, cradled masonite panel, etc.
- B. Use selective media and techniques to create at least five (5) original compositions.
- C. Exhibit sound craftsmanship and control of selective painting media inclusive of non-traditional materials.
- D. Critique paintings in relationship to painting media and techniques.
- E. Paint pictures in media of particular interest to the student.
- F. Acquire visual history of "contemporary" painting.
- G. Develop professional studio work ethic.
- H. Verbalize/visualize contemporary painting concepts with concerns to produce.
- I. Exhibit or display paintings properly prepared for public viewing.

III. Evaluation

- A. Pre-assessment

Instructors should check each student's prerequisites the first week of class; those who do not qualify should be sent back to Admissions.

- B. Challenge Exam

There is no challenge exam for this course.

C. Post-assessment

Each student's grade will be determined by the instructor upon successful completion of the course objectives. Instructors will maintain adequate records of student progress according to the guidelines established by the college.

D. Remediation

Remediation will be determined by the individual instructor. During this time the student is encouraged to seek the advice of the instructor. Remedial work or study will not be in place of regular open studio or outside study/practice activities.
