I. Catalog Description

Explores using basic techniques in jewelry and art metals construction. (2:4). Lab fee.

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Identify the basic terminology of metalsmithing and use it effectively to express his/her ideas verbally.
- B. Describe basic metalsmithing techniques.
- C. Identity the basic technical metalsmithing skills such as sawing, simple forming, silver soldering, cold connections, surface finishes, surface texturing treatments, and metal patination. Develop good craftsmanship and working habits needed to achieve strong three-dimensional visual statements.
- E. Create properly composed, well balanced three-dimensional designs using metal and various materials.
- F. Recognize a well-crafted piece of art.
- G. Effectively apply basic metalsmithing skills and techniques to create his/her own threedimensional statements.

III. Evaluation

A. Pre-assessment

Instructors should check each student's prerequisites the first week of class; those who do not qualify should be sent back to Admissions.

B. Challenge Exam

There is no challenge exam for this course.

C. Post-assessment

Each student's grade will be determined by the instructor upon successful completion of the course objectives. Instructors will maintain adequate records of student progress according to the guidelines established by the college.

D. Remediation

Remediation will be determined by the individual instructor. During this time the student is encouraged to seek the advice of the instructor. Remedial work or study will not be in place of regular open studio or outside study/practice activities.
