I. Catalog Description

Examines a survey of American literature from the Civil War to the present. Students will study works of prose, poetry, drama, and fiction in relation to their historical and cultural contexts. Texts will be selected from among a diverse group of authors for what they reflect and reveal about the evolving American experience and character. ENGL 2327 is not required in order to enroll in ENGL 2328. **Prerequisite:** ENGL 1301 with a "C" or better. (3:0).

II. Course Objectives

Upon satisfactory completion of this course the student will be able to accomplish the following:

- A. Explain the relationship between authors and their works in the context of the historical, social, and philosophical milieu.
- B. Identify major trends of thought and literature in each period studied: i.e., American Literature 1860-1914, American Literature between the Wars 1914-1945, and American Literature since 1945.
- C. Analyze and understand works of each author studied.
- D. Define literary terms and understand their practical application.
- E. Successfully articulate in writing his/her responses and interpretations of literary works through the writing of critical essays, research papers, journals, or a combination of these.
- F. (Recommended) Attend at least one interpretive performance of a piece of literature from the period, (poetry reading, play, film, etc).

Unit Titles

- A. American Literature 1860-1914
- B. American Literature between the Wars 1914-1945
- C. American Literature since 1945

Note: Unit titles may be adjusted according to the current text.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Identify key ideas, representative authors and works, significant historical or cultural events, and characteristic perspectives or attitudes expressed in the literature of different periods or regions.
- 2. Analyze literary works as expressions of individual or communal values within the social, political, cultural, or religious contexts of different literary periods.

- 3. Demonstrate knowledge of the development of characteristic forms or styles of expression during different historical periods or in different regions.
- 4. Articulate the aesthetic principles that guide the scope and variety of works in the arts and humanities.
- 5. Write research-based critical papers about the assigned readings in clear and grammatically correct prose, using various critical approaches to literature.

IV. Evaluation

A. Pre-assessment

Instructors should check each student's prerequisites the first week of class; those who do not qualify should be sent back to Admissions.

- B. Post-assessment
 - 1. The instructor will maintain a continuous record of each student's progress.
 - 2. Students should be evaluated periodically throughout the semester.
 - 3. The instructor will determine the weight of each graded assignment.
 - 4. Instructors will require writing assignments other than quizzes and formal exams.
 - 5. Plagiarism is both intellectual theft and academic dishonesty and will not be tolerated. Any work that is plagiarized could result in failure of the course. See the Student Handbook.
- C. Remediation

This is left to the discretion of individual instructors. Some instructors permit students to re-write major writing assignments. Students needing assistance with writing problems are encouraged to contact the instructor. Assistance is also available through the Writing Center.
