I. Catalog Description

Continues presentation of a string and brass ensemble which performs traditional folk music and modern Mexican music. Membership is open; previous music experience and proficiency with instruments required. Includes performances for special occasions on and off campus. Three rehearsal hours-per-week. **Prerequisite: MUEN 1131. (0:3). Course fee required.**

II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Participate in public performances of traditional and modern mariachi music.
- B. Play mariachi music literature in various styles as indicated by the music selected.
- C. Apply the principles and techniques of mariachi music as indicated in the latest trends.
- D. Demonstrate principles of stage projection and performance behavior appropriate to mariachi music ensembles.

III. Evaluation

Course evaluation is based on subjective appraisal by the instructor of:

- A. Attendance at and cooperative participation in daily class sessions.
- B. Attendance at and cooperative participation in performances and rehearsals. The student must attend rehearsals and performances. The schedule of rehearsals and performances is listed in the Instructor's Course Requirements.
- C. Application of principles of mariachi ensemble performance: intonation, rhythm accuracy and interpretation.
- D. Application of principles of stage projection and desirable performance behavior in performances.
- E. The final grade will be determined: Each student is initially assumed to have an "A". Failure to attend any one public performance or rehearsal for a public performance will lower the letter grade by two letters Unsatisfactory efforts in any of A, C, or D above will lower the letter grade by one letter.
- F. Since there are no written assignments or formal tests in mariachi, a policy on makeup of work is not applicable.
- G. Regular attendance in mandatory. Three unexcused absences will be grounds for being dropped from the course.
