### I. Catalog Description

Provides the computer applications specific software (Microsoft Office Outlook). Emphasizes the concurrent development of office skills and computer knowledge. This course is designed to be repeated multiple times to improve student proficiency. Provides instruction in creating and viewing messages; scheduling appointment and tasks; managing messages; creating and managing contacts, tasks, and notes. This is a Microsoft Official Academic Course (MOAC) program that prepares students to take the Microsoft Office Specialist (MOS) certification exam. The MOS exam is a global certification that validates students' skills. To be certified, the exam must be taken from a third-party testing company. **(1:1)**.

### II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Describe and demonstrate how to use OneNote, SWAY, and Office Mix.
- B. Illustrate the current version of Microsoft's operating system. **1.** Identify apps in Office.
- C. Identify components of the Microsoft Office Ribbon.
- D. Create folders. Perform tasks using Microsoft Office apps.
- E. Use the Help function
- F. Identify key terms used in Microsoft Outlook.
- G. Set up Outlook.
- H. Describe the Outlook Windows environment.
- I. Launch Outlook from the start menu and taskbar.
- J. Change Outlook's view to mail, current, calendar, and contact folders and by work week, week, month, task, and notes folders using the Options function.
- K. Compose and send email messages.
- L. Work with incoming messages.
- M. Respond to messages.
- N. Organize messages with Outlook folders.
- O. Create and edit appointments in the calendar.
- P. Schedule events, i.e., one-time event or recurring events.
- Q. Schedule meetings, such as, importing an iCalendar File.
- R. Print calendars in different view.
- S. Save and share the calendar and iCalendar file.
- T. Create and edit a Contact list.
- U. View and sort a Contact List.
- V. Search for a Contact.

- W. Create a group Contact list.
- X. Print the Contact list.
- Y. Create a Task.
- Z. Categorize Tasks.
- AA. Categorize email messages.
- BB. Manage Task
- CC. Choose and display print views.
- DD. Use Notes.
- EE. Discuss how to add new email accounts.
- FF. Customize email messages.
- GG. Create email signatures.
- HH. Assign email signatures to a single message or all messages.
