#### I. Catalog Description

Provides the review of concepts required of licensure examination and entry into the practice of professional nursing. Includes review of application of National Council Licensure Examination for Registered Nurses (NCLEX-RN) test plan, assessment of knowledge deficits, and remediation. Prepares the student to use all steps of the Nursing Process. NOTE: Students must successfully complete RNSG1343 and RNSG 2162 to take\stay enrolled in RNSG 2130 and RNSG 2221 and RNSG 2261. A grade of "C" or better is required in this course to take the next course. Prerequisites: RNSG 2201 and RNSG 2262 and RNSG 2308 and RNSG 2263 or RNSG 1262 and RNSG 1327 and RNSG 1347 and RNSG 1144. . Corequisites: RNSG 1343 and RNSG 2162. (1:1). Lab fee.

#### **II.** Course Objectives

Upon satisfactory completion of the course, the student will be able to:

#### A. Unit I: Test Prep/Test Taking Strategies

- 1. Analyze the different types of questions on the NCLEX-RN and differentiate the test taking strategies useful for arriving at the correct response for each. (SLO#1)
- 2. Examine how critical thinking relates to the NCLEX-RN test plan.(SLO#1)

#### B. Unit II: NCLEX-RN Test Plan

- 1. Analyze and direct nursing care that enhances the care delivery setting to protect the patient and health care personnel through the management of care.(SLO#3)
- 2. Determine safety guidelines and infection control that protect patients and health care personnel from health and environmental hazard. (SLO#3&5)
- 3. Examine the provision and direction of nursing care of the patient that incorporates knowledge of expected growth and development principles; prevention and/or early detection of health problems; and strategies to achieve optimal health. (SLO#3&6)
- 4. Critique nursing measures that promotes and supports the emotional, mental and social wellbeing of the patient experiencing stressful events, as well as patients with acute or chronic mental illness. (SLO#3&6)
- 5. Describe basic care that provides comfort and assistance in the patient's performance of activities of daily living. (SLO#3)
- 6. Summarize the nurse's role in the safe provision of care related to the administration of medications and parental therapies. (SLO# 3)

- 7. Examines the nurse's ability to reduce the likelihood that patients will develop complications or health problems related to existing conditions, treatments or procedures.(SLO#6)
- 8. Utilize the knowledge of physiological adaptation to manage and provide nursing care for patients with acute, chronic or life threatening physical health conditions.(SLO#6)

#### Unit III: Texas Jurisprudence Exam

- 1. Differentiate the roles and functions of the BON from those of nursing and healthcare specialty associations. SLO#4)
- 2. Identify actions by a nurse that could constitute unprofessional conduct and grounds for BON disciplinary action. (SLO#4)
- 3. Discuss rule 217.11, Standards of Nursing Practice and identify the standards that apply to all nurses; then differentiate the standards of practice for LVNs, RNs, and RNs with advanced practice authorization. (SLO#4)
- 4. Describe minimum due process for the nurse during incident-based peer review and safe harbor peer review. (SLO#4)
- 5. Explain how unprofessional conduct relates to the practice of nursing and why it can impact patient safety. (SLO#4)

#### D. Unit V: Laboratory Skills/Quizzes/Assignments

- 1. Apply test-taking strategies to help improve examination grades and increase scores on the ATI proctored/practice assessments.(SLO#1)
- 3. Analyze areas of weakness on the ATI predictor assessment and develop a plan of action to improve these areas. (SLO#1)
- 4. Utilizing time management skills develop a calendar for this semester. (SLO#1)
- 5. Create an action plan for test preparation between graduation date and the date of NCLEX-RN test date. (SLO#1)

#### III. THECB Learning Outcomes (WECM)

- 1. Apply knowledge, skills, and understanding of critical concepts required for entry into professional nursing.

#### IV. Evaluation

A. Proficiency Exam

Any student wishing to do a Proficiency Exam for a nursing course should speak to the ADN Program Coordinator and/or to the Nursing Counselor. All nursing courses can be challenged with the exception of RNSG 2221/2261, Management of Client Care (Theory and Clinical) if available. (See College Proficiency Exam Procedure).

B. Articulation

Articulated credit from many area high schools is available for graduates with high school health occupations courses. Students who have previously completed a Practical Nursing Program will be able to transfer their practical nursing courses to this program under the Texas Nursing Articulation Plan.

#### C. ATI Assessment

Students are required to take the Fundamentals, Pharmacology, Mental Health, Adult Medical Surgical, Nursing Care of Children, Maternal Newborn, Leadership, Nutrition and Community Practice Assessments (ATI) Assessment Technologies Institute, as well as the proctored Fundamentals, Pharmacology, Mental Health, Adult Medical Surgical, Nursing Care of Children, Maternal Newborn, Leadership, Nutrition, Gerontology and Community Prior to taking the Proctored Assessments, the student must score at least an 85% on the <u>practice</u> assessments. The practice test may be taken on any computer at any time and may be retaken until the student scores at least an 85% (although 24 hours must pass prior to retesting). **However students must complete a focused review on the practice assessment on any items missed prior to retesting and before taking the Proctored Assessment.** Students who would otherwise pass the course but (a) cannot take the proctored test on its scheduled date/time secondary to not scoring at least 85% on the practice test, or not completing the required focus review \*\* or (b) do not take the proctored test on its scheduled date/time will receive an "Incomplete" in the course. Incomplete grades will be resolved at the instructor's convenience. (Note: Students who arrive late to the proctored test will <u>not</u> be allowed to take it.)

Students must create an account at the ATI website (<u>www.atitesting.com</u>) at the start of the semester and keep a record of their user ID/password.

# Students, who do not take the ATI assessment at the scheduled time/date or have not completed the required remediation, will receive an incomplete grade for the classes.

Students will receive an Exam Grade according to their achievement levels on the <u>Fundamentals, Pharmacology, Mental Health, Adult Medical Surgical, Nursing Care of</u> <u>Children, Maternal Newborn, Leadership, Nutrition, Gerontology and Community</u> <u>Proctored Assessments</u>. An average level of 3 will be 90, an average level 2 will be 85, an average level 1 will be 77, and an average level below 1 will be 69.

#### The proctored assessments may be taken only once.

\*\* Focus reviews must be done for the Fundamentals, Pharmacology, Mental Health, Adult Medical Surgical, Nursing Care of Children, Maternal Newborn, Leadership, Nutrition, Gerontology and Community practice ATI assessments with an 85% or less grade.

\*\*\*All students must complete a Focused Review for the Fundamentals, Pharmacology, Mental Health, Adult Medical Surgical, Nursing Care of Children, Maternal Newborn, Leadership, Nutrition, Gerontology and Community proctored assessments for course completion.

\* The quiz grade will be your first attempt of the ATI practice assessments. ATI practice assessments may be taken as many times as desired. However students <u>must</u> complete a focused review on any practice assessment with a grade of less than 85% prior to retesting. On the Pharmacology, Community Health and Nutrition practice assessments you must achieve an 85% prior to taking the proctored assessment. An 85% grade must be achieved on all practice assessments for course completion.

\*\* All Proctored, Practice and Remediation must be completed during this semester only; no previous work will be counted.

#### E. Unit Exams

There will be nine (9) unit examinations, a midterm and a final exam. The unit exam grades will be derived from the nine (9) Proctored ATI Assessments (the Fundamentals, Pharmacology, Mental Health, Adult Medical Surgical, Nursing Care of Children, Maternal Newborn, Leadership, Nutrition, Gerontology and Community). The mid-term and the final exam will consist of the ATI Comprehensive Predictor Assessment.

\* ATI practice assessments: the Fundamentals, Pharmacology, Mental Health, Adult Medical Surgical, Nursing Care of Children, Maternal Newborn, Leadership, Nutrition and Community and Comprehensive Predictor you must achieve an 85% before you will be allowed to take the Proctored Assessment. However students <u>must</u> complete a focused review on the practice assessment with any grade less than 85% prior to retesting.

\*\* All Proctored, Practice and Remediation must be completed during this semester only; no previous work will be counted.

#### F. Course Grade

The course grade will be determined by:
