I. Catalog Description

Introduces basic techniques of pottery and ceramic materials. Includes hand-building techniques, glazing and other surface treatments, and kiln firing procedures. May include an introduction to the potter's wheel. **(2:4). Lab fee.**

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Use basic handbuilding techniques (pinch, coil, slab, mold).
- B. Create and apply basic surface design techniques (stamp, carve, spring, smooth).
- C. Construct clay forms that fit together physically.
- D. Construct clay forms that fit together with respect to meaning.
- E. Construct large and/or complex sculptural clay forms expressing content.
- F. Construct forms that replicate an historic clay artwork.
- G. Prepare and apply glazes, stains, and paint to bisqueware.
- H. Load and unload kilns, explain the firing process for clay.
- I. Participate in the presentation of completed clay works.
- J. Demonstrate and understanding of relevant vocabulary, theory, and history.
