II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Explain the development of and building methods for constructing a Green Building, such as sustainable construction, green building progress, and obstacles in development.
- B. Identify Green Building foundations such as lighting, plumbing, heating, ventilation and air conditioning, roofs, and environmental hazards.
- C. Identify the many Green Building Assessment protocols.
- D. Apply the Green Building Process.

III. THECB Learning Outcomes (WECM)

- 1. Explain the concept of green building.
- 2. Identify materials to build exterior and interior systems that reflect sustainable building concepts.
- 3. Explore smart energy technologies and their effects on energy usage.
