I. Catalog Description

Provides an application of class concepts taught in introductory media production and writing classes, culminating in the execution of media project in the student’s field of study. **(3:0)**.

II. Course Objectives

- A. Unit I. Pre-production
 - 1. Generate ideas using a variety of brainstorming and free-thinking methods.
 - 2. Perform background research on the topic to understand how topic has been executed in the past and to determine how it will be treated now.
 - 3. Craft a persuasive treatment and demonstrate a good understanding of the “pitching” process.
 - 4. Prepare pre-production elements, such as outlines, scripts, and storyboards.

- B. Unit II. Production
 - 1. Interact professionally with a client, peers, and on-camera talent to achieve the desired final product.
 - 2. Identify the different elements necessary to produce a professional final project.
 - 3. Identify and execute the different stages of a project, from conception to completion.

- C. Unit III. Post-production
 - 1. Compile production elements together in a cohesive manner to create a rough edit of the project.
 - 2. Incorporate feedback given of rough draft of the project into the final project.
 - 3. Deliver projects independently, meeting the demands of real-world deadlines.
 - 4. Demonstrate an awareness of project performance and the application of it to improve future projects

III. Evaluation

- A. Learning Activities

Students will participate in a variety of learning activities throughout the semester that will track their progress toward meeting course objectives, such as the following: in-class assignments and quizzes, a research review of related professional projects in the field, brainstorming activities,

project treatments and proposals, a final project, and a self-reflection paper relating to the process. Depending on the course instructor, all of these activities or only a selection may be used
