### I. Catalog Description

Provides in-depth coverage of the theory and practice of skin care, facials and cosmetics. Successful completion of the first semester courses required prior to taking this course. A passing grade is required in this course to take the third semester courses. **Prerequisite: CSME 1505. (2:7). Lab Fee. Professional Practice Insurance Required.**

### II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Demonstrate good customer service and a professional attitude.
- B. Explain the differences between sterilization and disinfection.
- C. Describe the structure and composition of the skin and the difference between disorders and diseases.
- D. Examine why chemistry is important and review the pH scale.
- E. Analyze the different skin types and determine proper treatment and aftercare.
- F. Perform the different types of massage movements and identify their benefits.
- G. Apply a facial with or without the aid of a facial machine.
- H. Demonstrate facial machine procedure and review its various uses.
- I. Explain the benefits and uses of various cosmetics.
- J. Perform advanced skin care services.
- K. Use appropriate technique for each chemical service.

### III. THECB Learning Outcomes (WECM)

1. Define terminology related to the skin, products, and treatments.
2. Demonstrate applications related to skin care and cosmetics.
3. Practice safety and sanitation according to the laws and rules of the state licensing agency.
4. Exhibit workplace competencies in skin care and cosmetics.

#### **IV. Evaluation**

##### **A. Grading Criteria**

Students are assigned theory study and a minimum number of practical experiences required for course completion. Theory (lecture) is evaluated after each unit of study by an exam or quiz. Practical assignments (lab) are evaluated as completed. Practical skills are evaluated according to state requirements or instructor procedures. The Texas Department of Licensing & Regulations (TDLR) establishes practical performance standards.

Make-up tests will be given according to Departmental Policies. *There will be no make-up testing for failed exams.*

The overall Semester grade is evaluated as follows: 50% Lecture and 50% Lab work.
