**I. Catalog Description**

Provides advanced concepts and practice of hair cutting. Includes topics on utilizing scissors, razor, and/or clippers. Successful completion of the first semester courses required prior to taking this course. A passing grade is required in this course to take the third semester courses. **Prerequisite: CSME 1505. (3:2). Lab fee. Professional Practice Insurance required.**

**II. Course Objectives**

Upon satisfactory completion of this course the student will be able to:

- A. Perform the use of various cutting tools to include shears, razor, clippers, trimmers, and texturizing shears.
- B. Demonstrate a basic blended, graduated men’s cut and perform texturizing/thinning techniques.
- C. Practice and establish a systematic procedure for haircutting to include hair growth patterns and textures.
- D. Use correct shear/hand positions to help prevent CTD’S (cumulative trauma disorders).
- E. Demonstrate cutting angles, body and head position, partings, and the use of cutting tools and reference points.
- F. Identify the various clipper guard sizes used for length variation when doing a clipper haircut.
- G. Establish client preference and recommend the most appropriate haircut for client’s face shape, hair type, and trends.
- H. Educate client on home maintenance.
- I. Recommend follow up appointments to customer.
- J. Practice all safety measures.
- K. Apply professional terminology.
- L. Cut wet and dry hair.
- M. Duplicate style from photo.

#### **IV. Evaluation**

##### **A. Grading Criteria**

Students are assigned theory study and a minimum number of practical experiences required for course completion. Theory (lecture) is evaluated after each unit of study by an exam or quiz. Practical assignments (lab) are evaluated as completed. Practical skills are evaluated according to state requirements or instructor procedures. The Texas Department of Licensing & Regulations (TDLR) establishes practical performance standards.

Make-up tests will be given according to Departmental Policies. *There will be no make-up testing for failed exams.*

The overall Semester grade is evaluated as follows: 50% Lecture and 50% Lab work.
