I. Catalog Description

Focuses on technical production where students receive credit for working on some aspect of play production. Focuses on developing hands-on experience with lighting and sound. **(0:3). Lab fee.**

II. Course Objectives

Upon satisfactory of this course, the students will be able to:

- A. Work before an audience
- B. Follow the actual process of a theatrical performance:
 - 1. Play selection
 - 2. Casting
 - 3. Live memorization
 - 4. Blocking-“Stage Movement”
 - 5. Characterization
 - 6. Costuming
 - 7. Properties handling
 - 8. Lightning production
 - 9. Sound design
 - 10. Set construction and/or set up
 - 11. Strike- take down and storage
- C. Master four different tasks within play production. Students choose four different tasks for four separate semesters.
- D. Work in groups as members of cast and/or crew(s).
- E. Comprehend how an individual’s job relates to the whole experience.
- F. Work with different college and/or community performing groups, i.e. dance and music, as members of backstage and/or front –of- house crew(s).

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

1. Use collaboration in the creation of theatrical productions.
2. Demonstrate the practical application of appropriately leveled theatrical skills and procedures.
3. Apply critical thinking skills required for the creation of a theatrical production.

IV. Evaluation

A. Pre-assessment:

Instructors should check student's prerequisites the first week of class; those who do not qualify should be sent back to Admission.

B. Challenge Exam:

There is no challenge exam for this course.

C. Remediation:

Remediation will be determined by the individual's instructor. Students needing assistance with writing problems are encouraged to contact the instructor. In addition assistance is also available through the Writing Center.
