I. Catalog Description

Develops the basic skills and techniques of acting, including increased sensory awareness, ensemble performing, character analysis, and script analysis. Emphasizes the mechanics of voice, body, emotion, and analysis from a variety of acting styles and schools of thought. A studio approach. Includes the actor’s process for rehearsal and performance preparation. Performance rehearsal lab participation is required for all students registered for Acting I. **(3:0)**.

II. Course Objectives

Upon satisfactory of this course, the students will be able to:

- A. Participate in the art of theatrical performance.
- B. Portray a variety of characters in order to enhance acting ability.
- C. Study, analyze and perform a minimum of three monologues, soliloquies or solo performance.
- D. Study, analyze and perform a minimum of three duet scenes with a partner of the class.
- E. Study, analyze and perform one ensemble selection where students show the “group” experience of performance.
- F. Study, analyze and learn about themselves as individuals in order to accurately portray other characters.
- G. Participate in theatrical games in order to ease the tension and provide comfortable performance atmosphere.
- H. Improvise real life situations in order to build quick character traits in a spontaneous atmosphere.
- I. Improvise implausible situations in order to build spontaneity, creativity and imagination.
- J. Develop a sense of pride, self-worth and accomplishment.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Analyze scripts from the viewpoint of the actor.
- 2. Analyze, develop, and perform a character.
- 3. Demonstrate effective and safe use of the voice and body.
- 4. Define and discuss terms and concepts using the vocabulary of theater.
- 5. Perform at an appropriately skilled level in ensemble building exercises, scenes and final projects, which may include participation in plays.
