I. Catalog Description

Studies drug classifications actions, therapeutic uses, adverse effects, routes of administration, and calculation of dosages. A grade of "C" or better is required in this course to take the next course and/or for this course to be eligible for "course completion" credit or eligibility to take licensing exam. (2:3). Lab fee. Professional Practice Insurance required.

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Identify the concepts related to basic pharmacology, including historical perspective, basic terms, sources of drugs, drug classifications, and drug nomenclature.
- B. Discuss legislative acts controlling drug use in the United States.
- C. Describe principles and routes safe medication administration and perform drug calculations.
- D. Describe the cardiovascular system to include anatomy and physiology and drugs affecting this system.
- E. Describe the autonomic nervous system to include the sympathetic and parasympathetic functions and drugs affecting this system.
- F. Identify drugs affecting the renal, endocrine, respiratory, reproductive, gastrointestinal, and central nervous systems; skeletal muscle relaxants; antibiotics; drugs used to manage poisoning; and HIV therapy.
- G. Discuss the paramedic's responsibilities and scope of management pertinent to the administration of medications.

III. THECB Learning Outcomes (WECM)

Upon completing this course, the student will be able to:

- 1. Categorize the classification of drugs.
- 2. Calculate drug dosages.
- 3. Identify the therapeutic use, routes of administration, indications, contraindications, and adverse effects.
