I. Catalog Description

Focuses on Standard English grammar usage for academic purposes. Open only to nonnative speakers. Intermediate to Advanced. May not be counted toward graduation requirements. A grade of a “C” or better will be required for advancement to the next course. **Prerequisite: Assessment of English language proficiency or ESOL 0335. (3:1). Lab fee.**

II. Course Objectives

Since this class is designed to prepare non-native speakers of English for academic courses, students are expected to use English in class at an appropriate level. Writing, reading, grammar, and listening and speaking activities will be incorporated throughout the course.

Upon satisfactory completion of this course, the student will be able to:

- A. Use the following language structures in activities that incorporate reading, writing, grammar, listening, and speaking:
1. Present, past, present progressive, future, and past progressive tenses
 2. Wh- questions
 3. Imperatives
 4. Use of modals: Suggestion, ability, possibility, permission, request, and advice,
 5. Adverbs of manner and frequency
 6. Conditional: First and second
 7. Present perfect tense
 8. Count and non-count nouns
 9. Pronouns and adjectives
 10. Phrasal verbs
 11. Present passive voice
 12. Comparatives and superlatives
- B. Use the following mechanics in writing:
1. Spelling
 2. Punctuation
 3. Capitalization
 4. Correct word order and word choice

5. High-intermediate to advanced vocabulary

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students (**at the appropriate level**) will:

1. Use verb tenses and voice with proficiency.
2. Use simple, compound, and complex sentences structures including phrases and clauses with proficiency.
3. Use parts of speech (nouns, pronouns, verbs, adjectives, adverbs, prepositions, interjections, conjunctions) and determiners (quantifiers, articles, demonstratives, possessives) appropriately and with proficiency.
4. Use appropriate word choice, word form, and word order with proficiency.

IV. Evaluation

A. Placement

Enrollment in ESOL 0336 is determined by placement test score or successful completion of ESOL 0335.

B. Assessment

1. The instructor is to maintain a continuous record of each student's achievements. Students will demonstrate successful achievement of the course objectives in course work and lab participation.
2. Students must have a 70% or higher in the course to take the course Exit Exam and must pass the Exit Exam with a score of 70% or better. If a student does not pass the first Exit Exam, they will be given a second similar exam. If a student does not pass one of these two Exit Exams, the student will receive a D and must repeat the course to advance. A grade of C or higher is required to advance to the next level.
3. Students are required to complete all lab activities for this course. Refer to lab manual for details.

- C. Activities such as assignments, tests, and/or quizzes will be at least 85% of the course grade. There will be a minimum of six to eight graded activities for this course. No more than 15% of the grade will be based on lab and attendance.
