I. Catalog Description

Develops skills in fashion figure drawing with emphasis on fashion details and body movement. Instructs in illustrating a wide variety of clothing on the fashion model in various media including computer-aided techniques. **Prerequisite: FSHD 1322. (2:2). Lab fee.**

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to

- A. Unit I. Skill Development in Fashion Drawing
 - 1. Use basic drawing skills to illustrate fashion detail.
 - 2. Manipulate the fashion figure to represent body movement.
 - 3. Develop variations on a concept.

- B. Unit II. Rendering Clothing
 - 1. Confidently render a wide variety of fabric types and clothing silhouettes.
 - 2. Use various appropriate media including computer-aided techniques to enhance idea communication.
 - 3. Conceptualize and articulate a visual design.
 - 4. Research and devise alternative media to convey concepts.
 - 5. Utilize illustration programs
 - 6. Back up data

- 1. Develop detailed matted illustrations of the fashion figure and face.
- 2. Demonstrate fashion rendering skills with various color and black and white media.
- 3. Produce a computer generated fashion illustration.
