I. Catalog Description

Studies three-dimensional fashion design conceptualization by draping in muslin or fashion fabric directly on the dress form. Develops skills in observing grain of fabric, identifying drapable fabrics, and creating designs suitable for draping. Emphasizes good design and commercial value. Presents major fashion designers' draping techniques. **Prerequisite: FSHN 1315. (2:3). Lab fee.**

II. Course Objectives

- A. Unit I. Grading Techniques
 - 1. Analyze patterns and determine growth requirements for sizing.
 - 2. Write and apply grade rules.
 - 3. Develop grade rule tables.
 - 4. Use a Grad-o-matic machine.
 - 5. Determine the best method of grading for a given style.
 - 6. Read and write grading specifications.
 - 7. Employ grading techniques to properly develop all necessary sizes for commercial patterns
 - 8. Use grading math skills.
 - 9. Perform Delta grading using the x,y axes.

- B. Unit II. Designing for Draping
 - 1. Create designs suitable for draping.
 - 2. Develop styles with good design and profitable commercial value.
 - 3. Analyze the variables which allow design variation.
 - 4. Redesign patterns to realize fashion change.
 - 5. Use fractions and decimals for pattern development and calculate fractions by calculator and in one's head.
 - 6. Respond appropriately to design feedback.

- C. Unit III. Draping the Three-Dimensional Design
 - 1. Establish appropriately sized muslins.
 - 2. Drape bodices, princess bodices, torso-length princess bodices, flounces, ruffles, and peplums.
 - 3. Draw concise and accurate finished patterns.
 - 4. Evaluate the need for pattern perfection.
 - 5. Measure garments and patterns
 - 6. Organize and read specification sheets

- D. Unit IV. Draping and Drafting Collars and Sleeves
 - 1. Establish appropriately sized muslins.
 - 2. Drape at least two (2) collars.
 - 3. Draft at least two (2) collars.
 - 4. Draft at least one (1) sleeve.
 - 5. Discuss the use of draping versus drafting in the development of collars and sleeves.
 - 6. Evaluate the advantages and disadvantages of draping versus drafting for the development of various collar and sleeve designs.
 - 7. Draw concise and accurate finished patterns.
 - 8. Evaluate the need for pattern perfection.
 - 9. Analyze sleeve shape in relation to the overall garment design.
 - 10. Evaluate the fit and balance of the sleeve.

- E. Unit V. Draping Styles of Major Fashion Designers
 - 1. Research the designs of major fashion designers.
 - 2. Analyze the draping styles of various major fashion designers.

- F. Unit VI. Draping a Bustier, Jacket, and Skirt Ensemble
 - 1. Create a style.
 - 2. Design a three-piece ensemble.
 - 3. Coordinate a jacket, bustier, and skirt.
 - 4. Illustrate a design in croquis format.
 - 5. Evaluate a design.
 - 6. Establish appropriately sized muslins.
 - 7. Estimate yardage requirements.
 - 8. Evaluate fit and balance.
 - 9. Determine the correctness of detail placement.
 - 10. Drape a bustier.
 - 11. Drape a jacket.
 - 12. Drape or draft a skirt.
 - 13. Use patternmaking skills to create a concise and accurate finished pattern.
 - 14. Demonstrate pattern perfection.
 - 15. Coordinate pattern details.
 - 16. Develop final patterns with all necessary notches, markings, and annotations.

- G. Unit VII. Constructing Finished Garments
 - 1. Determine yardage.
 - 2. Construct finished garments from original ideas, draped patterns, and drafted patterns.
 - 3. Evaluate fit and balance.
 - 4. Determine the correctness of detail placement.

- 1. Analyze the effect of fabric grain on draping.
- 2. Demonstrate basic draping techniques for a balanced garment.
- 3. Create draped bodices, collars, sleeves, skirts and/or pants.
- 4. Produce a fashion garment incorporating draping techniques.
- 5. Write and present a report on the draping techniques of a major fashion designer.
