### I.      **Catalog Description**

Instructs in draping various designs on a dress form and translating the designs to a muslin pattern. Teaches students three-dimensional conceptualization and includes construction of garments using patterns developed. **(2:2). Lab fee.**

- I. Unit IX. Draping the Six Gore Skirt
1. Establish appropriately sized muslin

- J. Unit X. Draping the Circular or Pegged Skirt
1. Establish appropriately sized muslin
  2. Drape a circular or pegged skirt front and back
  3. Draw a concise and accurate finished pattern
  4. Discuss the need for pattern perfection
  5. Measure garments and patterns
  6. Organize and read specification sheets
- K. Unit XI. Constructing the Finished Garments
1. Develop final patterns with all paper markings
  2. Construct finished garments from patterns developed
  3. Measure garments and patterns to determine accuracy.
  4. Grade patterns to industry standards.
