**I. Catalog Description**

Studies drug classifications, actions, therapeutic uses, adverse effects, routes of administration, and calculation of dosages. A grade of “C” or better is required in this course to take the next course. **(3:0)**.

**II. Course Objectives**

Upon satisfactory completion of this course, the student will be able to:

1. Discuss legal and professional considerations and responsibilities for drug manufacture, sale, administration, and storage.
2. Discuss principles, mechanisms, actions, and adverse effects related to administered drugs.
3. Describe the pharmacokinetics classified according to body systems.
4. Identify features and characteristics of over-the-counter drugs available to the public.
5. Describe indications, body responses, therapeutic uses, side effects, and drug interactions on the various body systems.
6. Discuss substance abuse as it relates to controlled and uncontrolled agents.

Upon completing this course, the student will be able to:

1. Categorize the classification of drugs.
2. Calculate drug dosages.
3. Identify the therapeutic use, routes of administration, indications, contraindications, and adverse effects.
