**I. Catalog Description**

Introduces two-and three-dimensional presentation, including drawing with one-and two-point perspectives, plans and elevations using a variety of media. **(2:2). Lab fee.**

**II. Course Objectives**

Upon satisfactory completion of this course, the student will be able to:

- A. Convert what he/she has learned in other interior design courses, including art and drafting, into practical drawing and presentation skills.
- B. Render one- and two-point perspective drawings.
- C. Produce quick sketches of these perspective drawings using his/her drawing skills.
- D. Articulate design concepts in professional manner to a prospective client.
- E. Utilize a variety of media for presentations
- F. Articulate design concepts in written, verbal, and automated formats.
- G. Plan and conduct presentations in front of instructor and peers
- H. Demonstrate professionalism as in following instructions, preparation, timeliness, responsibility, and good conduct.
- I. Identify and utilize tools, software, and equipment learned in all the interior design classes to include:
  - 1. Computers, printers, plotters, scanners, copiers, projectors, matboard cutter, labeler, glue gun, and pressmount
  - 2. Microsoft Word, Excel, PowerPoint, Publisher; Autocad; and Adobe Photoshop
  - 3. Architectural scale, triangles, manual drafting, mechanical pencils, furniture templates, and measuring tape
  - 4. Presentation materials-matboards, foamboard, adhesives, exacto knives, metal rulers, markers, vellum, and prisma color
- J. Plot 2-D and 3-D drawings
- K. Describe the function and maintenance of a fabric and product library.

- 2. Translate floor plans and elevations into three-dimensional drawings.
- 3. Create two- and three-dimensional presentation drawings and sketches.

#### **IV. Evaluation**

##### **A. Test & Projects**

1. Students will be given projects during the semester to include a mid-term project and a final project.
2. Mid-term project – space assigned by the instructor shall be designed by the student with the application of one- or two-point perspective design, as taught by the instructor including a black and white rendering shall be presented along with designed space.
3. Final project-shall be space assigned by the instructor. Perspective techniques taught during first half of course shall of course be applied with colored rendering of designed space. Presentation techniques shall be taught.
