I. Catalog Description

Provides career-related activities encountered in the student's area of specialization offered through an individualized agreement among the college, employer, and student. Under the supervision of the college and the employer, the student combines classroom learning with work experience. Includes a lecture component. **(1:9)**.

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Demonstrate good communication with co-workers from one shift to other
- B. Demonstrate multitasking
- C. Practice time management
- D. Maintain an organized work area
- E. Maintain up-to-date work orders and work log
- F. Perform the duties of an injection molding machine operator.
- G. Perform the duties of a plastic material handler.
- H. Perform the duties of a mold set-up technician.
- I. Inspect injection molded parts as required by quality department.
- J. Function as a troubleshooter/process plastics technician on the production floor.
- K. Interact with the various departments.
