### I. Catalog Description

Provides continuous experience in aural recognition of tone relations through sight-singing melodic dictation, and other aural training practices. **Prerequisite:** MUSI 1117. **Corequisite:** MUSI 2311. (1:1)

### II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Sight-Sing, using solfege syllables, and simultaneously conduct, various chromatic melodies.
- B. Accurately notate all elements of a chromatic melodic line of music (meter, barlines, pitch, rhythmic values) onto music staff paper.
- C. Accurately notate all elements of a two-part music excerpt (meter, barlines, pitch, rhythmic values) onto music staff paper.
- D. Aurally and visually identify, as well as notate on music staff paper: major, minor, augmented, and diminished triads and their inversions.
- E. Aurally and visually identify, as well as notate on music staff paper: major, dominant minor, half-diminished, and fully-diminished seventh chords and their inversions.
- F. Aurally and visually identify all chromatic compound intervals.
- G. Aurally identify, as well as notate on music staff paper the chords derived from a diatonic scale.
- H. Aurally identify, as well as notate on music staff paper common diatonic chord progressions.

### III. Evaluation

- A. Examinations and quizzes will be given to determine the student's progress and understanding of the course material. A minimum of three examinations, a comprehensive final examination, and three quizzes will be administered throughout the semester.
- B. To determine the student's final grade, the instructor will average test and quiz scores. Grades will be based on the following scale:

90 to 100 = A  
80 to 89 = B  
70 to 79 = C  
60 to 69 = D  
below 60 = F

- C. Attendance requirements will be specified by instructor and may be a factor in determining the final grade.
